

In this connection, you may kindly go through BIS LRS 2020 available at BIS website [www.bis.org.in](http://www.bis.org.in).

It may be noted that you are required to comply with the Terms & Conditions as laid down under item 5.0 of the BIS LRS 2020 and also the Undertaking given by you along with the application form. In case your laboratory is found violating any of the provisions of the Scheme or the undertaking given by you, the recognition of your laboratory may be suspended or your lab may be de-recognized by BIS. The conditions under which the laboratory can be suspended/deferred/expired or can be de-recognized are given under item 7.4 & 8 of BIS LRS 2020.

You are advised to get all the clauses of each ISs applied/coversed in BIS scope in your NABL accreditation scope within 1 year from the implementation of BIS LRS 2020 i.e. by 31 May 2021. Thereafter scope of the lab will be reviewed.

It may also be noted that this recognition does not bind BIS to make use of the test facilities available in your laboratory. However as and when required your test facilities would be utilized as decided by BIS from time to time.

Suspension of driver's license in Indiana The Indiana Department of Motor Vehicles (BMV) may suspend your driver's license for reasons ranging from non-compliance with insurance requirements to serious infractions such as drunk operating (OWI). You may not drive with a suspended or revoked license. Continue reading for information on common reasons for suspension of the license in Indiana and how to reinstate your driver's license. About your license suspended in IN Your license may be suspended for a variety of reasons. If you receive a suspension, you will receive a suspension notice that will explain that your driving privileges have been suspended and why, and will include details of your suspension and your rights. Below are the most common reasons for suspending the Indiana license. Attendance/Payment Failure This refers to failing to attend a subpoena or paying the fine related to traffic violations, such as speeding tickets. Your license suspension is indefinite; your driving privileges will be restored as soon as the court sends the necessary documentation to the BMV. Failure to comply with insurance requirements Your license is suspended if you cannot prove that you meet the state's insurance requirements. Your suspension will be for: 90 days. Or a year, for a repeat of the attack. Habitual Traffic Rapist A Habitual Traffic Violator (HTV) is one who commits 2 serious infractions or 3 serious infractions (see bullets below) within 10 years. HTV suspensions generally last 10 years; however, if 2 major bouts relate to OWI, the suspension is usually lifetime. You will be considered an HTV if: You commit 3 serious infractions within 10 years (e.g. drag racing, leaving the scene of an accident, OWI, etc.). You commit 2 serious crimes within 10 years resulting in injury or death (e.g., manslaughter, manslaughter or voluntary manslaughter, etc.). You accumulate 9 violations on the move, and one felony within 10 years. You drive with a license that's been suspended for HTV. NOTE: At this time, the court establishes the period of suspension of your license, which may be up to life. Operation While Intoxicated Your license may be suspended for driving with a blood alcohol content (BAC) above the legal limit and for refusing to do a chemical test. See "OWI suspensions in Indiana" below. Failure to complete a DSP or DDC You must complete a Driver Safety Program (DSP) or Defensive Driving Course (DDC) if you accumulate too many points in your driving record. Learn more about point accrual, DSP, and DDC on our DMV Points System page in Indiana. Not paying child support Your license is suspended indefinitely. Generally, your suspension lasts until you start making payments to satisfy the court. Writing bad checks Paying for BMV services with bad check leads to indefinite suspension of the license. Operating while suspended when your license is suspended can lead to being charged with misdemeanor or felony. Check driver's license status Your driving record includes everything from DMV points to traffic tickets as well as driver's license status—including whether you have a suspended driver's license. You are not the only one who can access your driving record. In addition to potential employers and background researchers, auto insurance companies will look at your driving record before setting car insurance quotes. The IN BMV offers visualized driving records (VDR) and official driving records (ODR). When you receive your suspension notice, IN BMV will notify you of whether you are eligible for an administrative hearing and, if eligible, how to file an appeal. Generally, this is called "administrative suspension itself" and is rendered by the BMV. Refusing: Up to 2 years. Failure: up to 180 days. To be convicted of operating drunk. Court and state laws base your period of suspension or revocation on: Your age. The number of the offence (e.g. first offence, offense, etc.) Your blood alcohol content (BAC). For example, you might have to complete steps for a point-related suspension that you would not have to complete for a suspension related to bad checks. If your meeting of for reinstatement says "indefinite", this means that you must take specific actions before you can re-establish your license. You will need to meet all requirements imposed by the BMV or the court that has suspended your license. IN BMV provides specific situation-specific license reinstatement information when you log in to your myBMV.com. There, you'll find reinstatement steps—including your specific reintegration rate. Proof of insurance If you are required to show proof of insurance, you will need to do so before re-establishing your license. For example, you may be required to submit a Current Insurance Statement (SR50) or a Future Financial Liability Test (SR22). Proof of insurance must be sent electronically by your insurance provider to the DMV before your license can be reinstated. Indiana Probationary or Disservice License The court determines whether you are eligible for an internship or difficulty license. If you are granted driving privileges in stages or probation, the court will submit an SR17 Form directly to the BMV. This form will tell BMV how long the difficulty license or evidential license will be valid and any related limits. Fees for Suspended Licenses in Indiana Your license reinstatement fees may vary depending on the reason for your driver's license suspension; however, your suspension paperwork will allow you to know your specific rate. You can pay your reinstatement fee online or by mail: Online: Use your myBMV.com. By mail: Complete and follow the instructions on the Reintegration Fee Submission Form. Payment accepted includes: Credit or debit card. Check or payment order to the Bureau of Motor Vehicles. DON'T SEND MONEY. Send everything to the address listed in the Reintegration Fee Coupon. CDL suspensions in Indiana Expect a proposed disqualification notice or a disqualification notice if you commit any of the violations below. Leave the scene of an accident. Commit a crime with a commercial vehicle. Acquire out-of-state convictions. Manufacture, sell or distribute controlled substances. Commit a serious traffic violation. Commit railroad crossing violations. Commit violations of order out of service. Commit hazardous materials and violations of out-of-service passenger orders. Aren't you a resident of Indiana?
